#### The Hottest Late Stage Companies

We are pleased to share the Q1 2021 edition of The Setter 30 – our ranking of the most highly sought-after pre-IPO companies in the global secondary market. The Setter 30 is based on a survey of over 500 leading global investors in late stage companies, as well as proactive interest that we have received from secondary buyers in the last several months.

While the deals on this list are the most frequently targeted by investors, they may not necessarily be the most easily found. For example, while Stripe, Databricks and Epic Games have many potential buyers, experience has proven that there is rarely if ever any supply of these shares on the market.

Our team and respondents noted a number of current trends reflected in the survey results. First, the mania surrounding all things crypto, is evidenced by the meteoric rise of Coinbase, the markets' renewed interest in Ripple, and recent frenzied bidding around Kraken, a crypto exchange rival for Coinbase that almost made the rankings. More broadly, fintech and payments continue to be very hot, with names like Stripe, Robinhood, Plaid, eToro and Klarna continuing to be market darlings. Artificial intelligence, robotics, gaming and remote learning remained hot areas of the market too.

With the success of many recent late-stage venture IPOs, any company announcing potential plans to go public has tended to instantly shoot to the top of our rankings. Among these on the current list are Robinhood, Grab, Toast, UiPath, Coinbase, Coursera, and Didi.
